About parking at Academy or riding in a carpool:

- If you're an Academy student parking at Fairfax High School, you need an Academy parking permit (even if you have one at your base school). Park in marked Academy spaces only. You may not park in visitor, staff, or FHS student parking.
- Your parking permit must be displayed at all times while you are on the Fairfax High School campus. It is not transferable and you may not share it with another student. Students can carpool; list your carpool vehicles on this form.
- An Academy parking permit costs \$67 per year. This fee is waived if you have purchased a permit at your base school. Fee is payable by check or exact change to Fairfax High School.
- Drivers and carpoolers enter and exit Fairfax High School at Door 10 and are not permitted entry through other doors.
- Students who commute to Academy in a private vehicle follow the FHS bell schedule as follows.
 AM classes: 8:10 a.m. – 9:38 a.m.
 Midday classes: 11:51 a.m. – 1:21 p.m.
 PM classes: 1:27 p.m. – 2:55 p.m.

Reminders:

- **Student vehicles on school grounds may be searched when there are reasonable grounds to believe that they contain illegal items or are in violation of the SR&R. Unauthorized leaving of school grounds will result in student vehicles being searched.**
- Fairfax High School/Academy is not responsible for stolen items. Students are discouraged from storing valuable items in their vehicles and asked to keep their vehicles locked while on Fairfax High School grounds.
- FCPS has no liability for students driving or riding in a private vehicle to and from Academy.

Penalties: Any violation of this Fairfax Academy parking agreement may result in either written warnings, temporary suspension of parking privileges, or the forfeiture of parking privileges for all persons registered to that vehicle or parking permit, without refund of permit cost, depending on the severity of the infraction.
