

### PARKING AGREEMENT 2021-2022

**NOTE:** This agreement serves as notification of the parking rules; there will be no other warnings prior to the correction of violations.

**Cost:** If a student has paid for a base school parking tag, it must be presented with this application, and there will be no cost for the Academy parking tag. If a student does not have a base school tag, the Fairfax Academy tag is \$67.00 per school year (non-refundable). Students who start driving during second quarter or later, please contact the Academy office directly for a pro-rated amount and to see if spaces are still available. Students who qualify for FCPS Free and Reduced program will be charged a lower price with proper documentation. Lost, stolen, or misplaced tags will be replaced at a fee of \$20.00.

**Privileges:** The purchaser of a Fairfax Academy parking tag will be allowed to park in an Academy parking space, which will be reserved for use during their specific Academy block. Students are encouraged to carpool, and one tag can be used for more than one car as long as the vehicles are registered at the time the tag is purchased.

**Rules:**

- Students are not permitted to park on Fairfax High School (FHS) grounds during the school day unless they have a tag from their base school and Fairfax Academy.
- All cars must always have the FCPS registered parking tag displayed while on FHS grounds.
- A photocopy of the student's valid driver's license or permit must be given with the application.
- While driving on school grounds, students must abide by the posted speed limit, 15 mph, and maintain control of their vehicle at all times. Students must also observe laws such as stopping behind buses with flashing lights, yielding to pedestrians, and not recklessly endangering themselves, or any FCPS students or staff on their way to and from school. Students are not allowed to ride on top of vehicles at any time on school grounds.
- Students are not allowed to paint or decorate their assigned parking spaces.
- Students can only go to their vehicle during their block if they have permission from the Academy office.
- Students are not permitted to leave FHS grounds unless properly checked out through the Academy office. Student Drivers are responsible for all passengers' actions. Passengers must also be checked out properly to leave school grounds.
- **Student vehicles on school grounds may be searched when there are reasonable grounds to believe that they contain illegal items or are in violation of the SR&R. Unauthorized leaving of school grounds will result in student vehicles being searched.**
- Fairfax Academy/FHS is not responsible for stolen items. Students are discouraged from storing valuable items in their vehicles and asked to keep their vehicles locked while on FHS grounds.
- **Academy drivers must park only in Academy parking spaces.** Do Not park in any STAFF, VISITOR or MAINTENANCE spaces.

**Penalties:** Any violation of this Fairfax Academy parking agreement may result in written warnings, "tickets," the issuance of a car "boot," temporary suspension of parking privileges, or the forfeiture of parking privileges for all persons registered to that vehicle or parking tag, without refund of cost, depending on the severity of the infraction.

- **Any vehicle on school grounds without a valid Fairfax Academy Parking Tag, or proper authorization, may be given a written warning, a "ticket" (\$25 fine), or car "boot" (\$50 fine). Vehicles with multiple parking violations will be towed off school grounds at owners' expense. SEE FHS FINANCE OFFICE TO PAY FINE.**
- Unauthorized leaving of school grounds by all students holding an FHS/Academy parking tag will result in loss of parking privileges for all vehicles registered to the tag holder for 30 calendar days for the first violation, and loss for the remainder of the school year for the second violation, without refund of parking tag cost.
- Your school record can affect your parking privileges. Student behavior during the course of the day, and attendance, can affect your parking privileges and may result in disciplinary action.
- Students caught buying and/or selling Fairfax High School parking tags without the school's knowledge will forfeit their tag and/or the privilege to purchase a tag for that school year.
- **Students will be charged in a Court of Law** for any violations of the State of Virginia Legal Codes.

**Agreement:** I hereby have read, discussed with my parent(s) or guardian(s), and agree to abide by all expectations of the above Fairfax High School Academy Parking Agreement. I also understand the penalties if I should choose to ignore this Agreement. By signing below I give consent to a search of my registered vehicle by any authorized school employee, should suspicion of prohibited activity arise. All the information provided on the attached form is true to the best of my knowledge. I understand that any attempt to falsify information will result in the removal of parking privileges.
